IMPORTANT INSTRUCTIONS:

Reshuffling of admission program for first year M Pharm on Vacant Seats

- 1) During Reshuffling, candidates shall not be allotted the seat which was available to him at the time of first counseling.
- 2) Candidate shall be offered only that seat which was closed at the time of first counselling to that particular candidate.
- 3) No separate form is required to be filled for reshuffling.
- 4) Candidates who remained present at the time of first counselling did not secure seat are eligible for reshuffling process.
- 5) Candidates who remained absent at the time of first counseling are eligible for reshuffling process.
- 6) Candidates willing to continue the existing admission taken in first counseling need not come for reshuffling program.
- 7) Candidates who have cancelled their admission at ACPC are not eligible for reshuffling.
- 8) Candidates shall have to report within 5 working days to the institute after getting admission from ACPC, otherwise the seat shall be treated as cancelled automatically.
- 9) Details of vacant seats shall be displayed on 6-9-2011 at 6.00 PM.
