## Announcement for ONLINE ADMISSION PROGRAMME FOR MBA AND MCA POST GRADUATE (FULL TIME) PROGRAMMES: YEAR 2021-22

For admission in the first year of Master of Business Administration (MBA) and Master of Computer Application (MCA) on State quota seats which includes all sanctioned seats of Government & Grant-in-Aid Colleges, 50% seats of sanctioned intake & surrendered seats of management quota of unaided Colleges of Gujarat, the State Government has decided to carry out **web based online admission process** for the academic year 2021-22. **The online registration through internet is mandatory for eligible candidates for participating in the admission process.** The aspiring candidates not having internet facility can avail the same at Cyber Space Centres designated by admission committee without paying any charges. (The list is available on committee's website [www.jacpcldce.ac.in](http://www.jacpcldce.ac.in))

### **Eligibility for Admission:**

The aspiring candidate shall have appeared in CMAT examination 2021 conducted by NTA (prescribed by AICTE) and shall have passed qualifying examination with minimum 50% (45% for SC/ST/SEBC/EWS) for MBA and MCA course.

### **[A] For 95% seats of total sanctioned intake of Government/Grant-in-Aid Institutions and 50% of total sanctioned intake of unaided Institutions:**

**For MBA:** A candidate shall have obtained minimum Qualification as mentioned above from recognized institutes/ universities duly stated in admission rules. For further details, please refer notifications related to admission rules issued by Government of Gujarat from time to time. All such notifications are available on the official website of committee.

**For MCA:** A candidate shall have passed the qualifying examination BCA/Bachelor Degree in Computer Science Engineering or Equivalent Degree OR Passed B.Sc/B.Com/B.A. with Mathematics or Business Mathematics or Statistics at (10+2) level or at Graduation level (With Additional bridge courses as per norms of Concerned University) from recognized institutes/ universities duly stated in admission rules. For further details, please refer notifications related to admission rules issued by Government of Gujarat from time to time. All such notifications are available on the official website of committee.

### **[B] For 5% seats of total sanctioned intake of Government/Grant-in-Aid Institutions:**

A candidate shall have obtained minimum Qualification as mentioned above from universities/institutes located in India (excluding Gujarat State) duly affiliated with any recognized university. For further details please refer notifications related to admission rules issued by Government of Gujarat from time to time. All such notifications are available on the official website of committee.

**Note: Candidate, who has appeared in qualifying examination and result is awaited/ pending, can also apply. However, committee may issue merit number/Admission in such case on provisional basis and admission will be finalised only if the candidate fulfills all the requirements & eligibility criteria as per Government of Gujarat notification and submit all necessary documents in the all manner deemed ask.**

### **Registration Process:**

- The online admission registration will begin from **today 12:00PM and will end on 27.07.2021 (5:00PM).**
- The candidate shall have to complete the registration process by uploading all relevant documents and paying registration fees (non-refundable) of INR 350/- for MBA or MCA course and Rs.500/- (for applying for Both MBA & MCA courses - MBC) through online mode only.
- Candidates seeking admission through admission committee for academic year 2021-22, shall have to register online on website [www.gujacpc.nic.in](http://www.gujacpc.nic.in) to become eligible for further admission process. Please note that no other means of registration are available.
- Candidate during the process of registration shall give undertaking of accepting provisional admission till verification of qualifying examination.
- There is no need to submit or verify any document in person. The entire admission process is completely online.
- The candidates are advised to visit the admission committee website, and Log-in to online admission portal through their User ID and password for checking various announcements, verification process and other guidelines on day today basis.
- Tuition Fee Weaver (TFW) as supernumerary seat is available for admission year 2021-22 for MBA-MCA course as per AICTE norms. Family income must not exceed INR 8 lacs for TFW seats. Students from any category can opt for admission under this scheme with valid income certificate.
- Candidates can obtain information like detailed notification of course, Advertisement, Video of document uploading, All type of announcement/ Notice, steps for entire process of online registration, last year cut-off, institute details, List of designated Cyber Space Centres, Admission schedule, Merit list, Allotment Result and All updated information related to admission process on the website [www.jacpcldce.ac.in](http://www.jacpcldce.ac.in).
- Candidate can register online through the website [www.gujacpc.nic.in](http://www.gujacpc.nic.in). Candidate must use this web site for payment of registration fees, choice filling, admission confirmation, payment of Token tuition fees for admission confirmation and for admission cancellation through candidate login ID and password.
- Designated Cyber Space Centres are for providing fee of cost online access for registration and document uploading (Time: 11:00AM to 5:00 PM for all working days). Candidate need not submit any physical documents at Cyber Space Centre.
